ELLA F-2 SCHOOLS TRIAL, WA GOVERNMENT SCHOOLS

Dear parent/guardian

A key part of the Australian Government's commitment to supporting language study is the Early Learning Languages Australia (ELLA) program.

Education Services Australia (ESA) manages the delivery of ELLA on behalf of the Australian Government Department of Education and Training.

Background

ELLA is a digital, play-based program that includes a series of interactive applications (apps) that make language learning engaging and interesting for children in preschool and the early years of schooling.

In 2018, approximately 2500 preschools chose to implement ELLA, with a reach of over 80,000 children.

Languages currently available are Arabic, Chinese (Mandarin), French, German, Hindi, Indonesian, Italian, Japanese, Modern Greek, Spanish and Vietnamese, with Turkish and Korean to come in 2020.

The Australian Government is providing additional funding to extend the program into schools through a trial for students in Foundation to Year 2 (F–2).

The objectives of the ELLA F-2 schools trial are:

- to introduce students in the early years of schooling to languages other than English in order to encourage language learning in later years
- to enable more students to access the benefits of language learning through digital technology.

ELLA is being trialled in 300 schools across Australia over the 2019–21 school years.

Each school will participate in the trial for the full three years, with Foundation students commencing in 2019, Year 1 students in 2020 and Year 2 students in 2021. Each school will select one language for the trial.

ELLA F-2 schools trial at your school

Your child's school has successfully applied to participate in the ELLA F-2 schools trial.

ESA and the Australian Government request permission for your child to participate in the trial beginning in 2019. Children cannot participate in the trial without written parent/guardian consent.

If you agree to your child participating in the trial:

- your child will have the opportunity to use the apps on a tablet device at certain times while at school
- your child's teacher or another staff member will be present when the tablet device is being used in the classroom
- personal data collected will be your child's first name and their photo or a photo of an object
 that has meaning to them (eg a sketch of themselves or another piece of their artwork), and
 this may be added to the tablet devices as their personal login/avatar; this information will
 only be accessed by the school and ESA, and will be deleted from the tablet devices at the end
 of the year
- usage data will be collected on the tablet device during your child's sessions and will be sent electronically to ESA periodically
- usage data relating to your child will be de-identified; that is, personal usage data will be disassociated from your child
- an independent evaluator may later be appointed by the Australian Government to undertake an assessment of the trial and deliver a report to the Australian Government; de-identified aggregate data would be shared with the independent evaluator
- the report to the Australian Government by the independent evaluator may be used to inform future government policy on the early learning of languages in Australia.

Participation in the trial is voluntary. If you agree to your child participating in the trial, you may subsequently withdraw your consent at any time during the trial by advising the school in writing. The school would then notify the ELLA helpdesk that your child has withdrawn. Your child's avatar would be deleted from the ELLA apps, which would delete all of your child's data from the system.

If you don't agree to your child participating in the trial, your child will not be able to access the ELLA apps but can still enjoy and participate in associated language learning experiences such as cooking, singing, cultural puzzles, stories, videos, inquiries, discussions and creative experiences.

You will not be paid for your child's participation in the trial. There is no cost to you for your child to participate in the trial.
